- Child Care provider cannot allow the children in their care to utilize any on-premises swimming facilities other than an 18 inch plastic wading pool. The swimming facility must be fenced on all four sides with a self-locking gate.
- Child Care provider must not own any of the following breeds of dog:
  - Rottweiler
  - Pit Bull
  - Doberman
  - Mastiff breeds
  - Mixed breeds where dominant breed is one of any above.
- The Liability Insurance covers all activities involving enrolled children. In addition to the common policy exclusions, there is no liability coverage for situations involving:
  - Swimming Pools
  - Animals
  - Trampolines
  - Mold ◦ Silica/Dust ◦ Lead or Asbestos
  - Transportation
  - Employment Related Practices
